## SALE RULES AND REGULATIONS

### SALE DATE & TIME

The Winnemucca Cow Dog Sale will be held immediately following the finals on Thursday, March 1, 2012. The estimated sale time is approximately 7:00 p.m.

ENTRY DEADLINE IS January 27, 2012. All certificates, cataloging information, and entry fee MUST accompany entries. Incomplete entries will be returned. Sale Committee reserves the right to refuse entries that, in their opinion, do not meet the quality requirements of this sale.

### FEES/COMMISSION

Entry fee is \$25.00 per animal consigned. Entry fee is non-refundable. **A \$10.00 per dog late fee will be assessed for entries received after January 27, 2012. Make checks payable to Ranch Hand Rodeo.** There is a \$25 fee for any NSF check returned. The commission is five percent (5%) of the gross sale. Payment on consignment will be mailed once the buyer's payment clears the bank, pursuant to normal banking practices, usually within fourteen (14) business days. Consignment checks will be made payable to the designated consignor.

### CONSIGNOR'S MEETING

A mandatory consignor's meeting will be held prior to the sale.

### AGE

Age limit is one to five years of age at time of sale.

### TRIAL PARTICIPATION

Sale dogs must participate in one of the three classes in the 2012 Winnemucca Cow Dog Trial.

### CHECK IN

Dogs must be checked in at the Sale Office by 3:00 p.m., Thursday, March 1, 2012.

### SIFT

Sale dogs may be sifted by the sifting committee, if they are found to be unfit or unsound.

### BUY BACK/NO BID/ NO SHOW

A minimum bid may be placed on a dog with the Sale Office by 3:00 p.m., Thursday, March 1, 2012. In the event of a buy back, no bid, or no show, the consignor will pay \$25 to the Sale Office prior to removing the dog from the grounds.

### TRANSFER OF OWNERSHIP

The consignor is responsible for the care and custody of the dog until the buyer takes possession. Consignors are required to work the dog with the buyer after the sale.

### HEALTH REQUIREMENTS

There will be a general health inspection carried out by the event veterinarian prior to the sale. A health form must be completed and submitted. You should attach your rabies certificate to the health form.

#### Required Vaccinations:

- Distemper
- Hepatitis
- Parvo Virus
- Rabies - \*\*Please attach a copy of your Rabies Certificate to your health form\*\*
- Heart Worm
- Frontline/Advantage
- Other: Include any additional vaccinations on your health form.

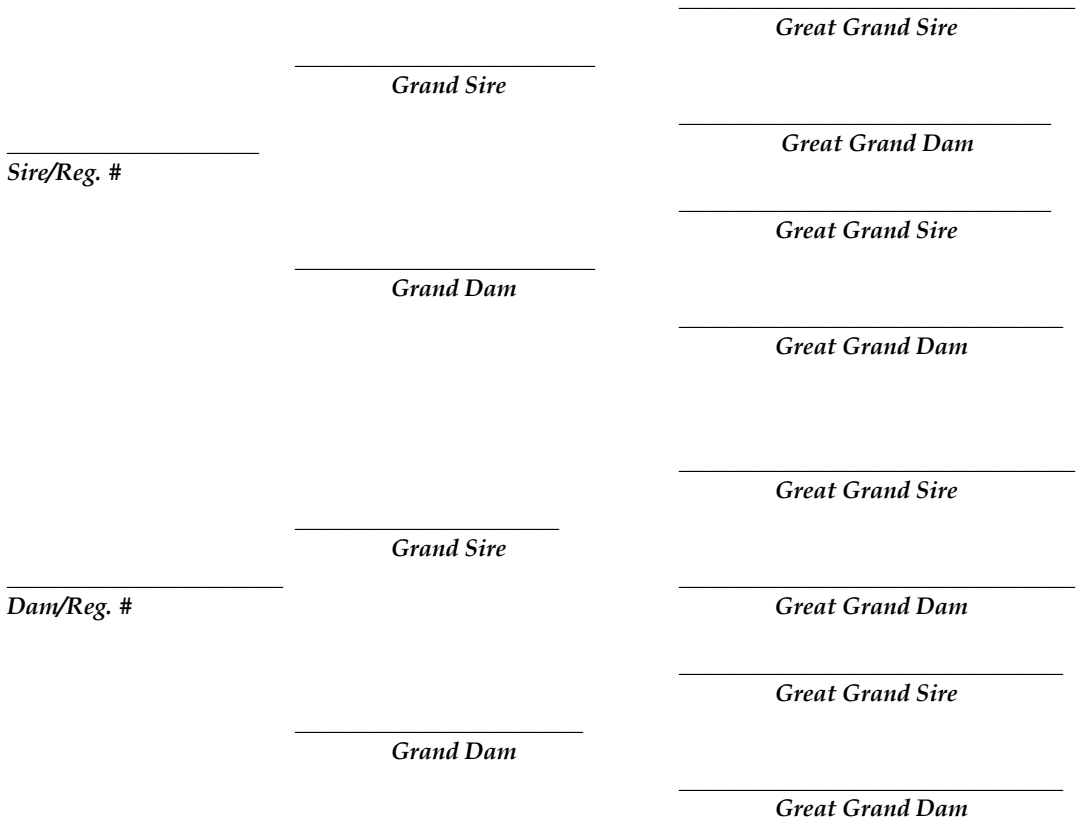
