\$160 entry fee for OPEN PRO CLASS. \$85 entry fee for RANCH CLASS. \$100 entry fee for BRACE CLASS. Entry fees include sanctioning and cattle fees. Listed and sanctioned by **USBCHA**. A portion of the proceeds will be donated to Humboldt County Search & Rescue. A RANCH CLASS dog is a dog that has never run in an Open Class. Limit of 2 dogs per handler per class. Points/time scoring. Handler must be on horseback. There will be one elimination round with the top five dogs advancing to the finals in the OPEN PRO and RANCH classes. There is no final round for the BRACE class. Mixed cattle will be used for each class. Finals for the RANCH and OPEN classes will start with a fresh score.
